# TESTING INFORMATION

Southeast Iowa Regional Law Enforcement Testing Center has scheduled Police Officer and/or Deputy testing which consists of two parts: an agility test and a written exam. These exams will be held on Saturday, June 3, 2017 beginning with the *agility testing* (see attached) at 8:00 a.m. in the gymnasium at Southeastern Community College located at 1015 South Gear Avenue in West Burlington, Iowa. If you pass all portions of the agility test, you will be eligible to take the *written test* which will be administered in Room 201 at 11:00 a.m. Applicants must pass all portions of the agility test and all portions of the written test to be eligible for further consideration by the law enforcement agencies.

Enclosed is the [Application To Test](#), which must be completed and received at the Burlington Police Department by 5:00 p.m. on May 19, 2017. If this form is not completed and received by this deadline, applicants will NOT BE ABLE TO PARTICIPATE IN THE TESTING. Additionally, we do not accept prior written or physical testing scores therefore this is the only opportunity to be considered for hire by these agencies.
